## How can the Supervised Visitation Program help your family?



### What is the Supervised Visitation Program?

Supervised Visitation is a program that works with the courts to provide a safe visitation setting for families in conflict.

### How long are the visits and when are they scheduled?

Visits are 1 to 3 hours in length, once per week. Visits are scheduled on Wednesday, Friday or Sunday evening 5-8 or Sunday afternoon 2:30-4:30 at a time convenient for both parents.

### Who are the staff?

Our programs are run with a combination of staff and volunteers. All personnel are trained to work with parents and children.



### Who are the clients?

The court may refer any family to our program in order to ensure safe visiting between children and their parent, grandparents, or siblings.

### How is the family referred?

Families are referred to the program usually through court orders. Once the order is issued, both parties should immediately call CRC to schedule a pre-service interview. Staff meets with both parties individually, and sometimes with the children, for a pre-visit orientation. During this interview, program rules are reviewed, paperwork is filled out and a schedule for visitation is established.

### Is there a fee?

Yes, The non-custodial visitor (unless a court order says differently) is required to pay a fee per visit, based on how many hours of visits and type of visit.



### How long does it take to complete the program?

It is at the discretion of the courts to determine how long a family will participate in the program. The court's decision will be based on the safety needs of the child(ren), the progress of the visits and perhaps other factors.
